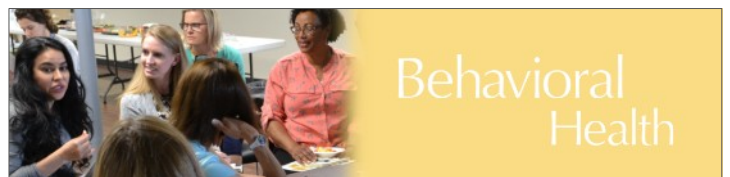
In January, April, July, and October, AHA held its Quarterly Community Meetings (three of them virtual), which offered a variety of topics and presenters.

Meetings are hosted by various community partners, and include education, networking, community announcements, and celebration. The 2020 meetings included topics and presentations such as the **Arapahoe County Self Help Legal Center, Center for Work Education and Employment, the 2020 Census, Aurora Wellness Court, the Food in Communities program, diabetes education, and voter outreach**, with an average attendance of 65 people.

A variety of organizations collaborate with AHA to improve access to oral health in Aurora. The work of Aurora Smiles includes **free dental screenings and fluoride varnish to kids**, and **information about how to find an affordable dental care home** in Aurora. In 2018, AHA received a three-year grant from the **Delta Dental Foundation of Colorado** to support the Aurora Smiles work. Aurora Smiles recently created a [resource flowchart](#) for adults to help navigate oral health services, including those who are uninsured or underinsured.



We are proud to introduce our **newest interest group**, which held its inaugural meeting in October, 2020. The meeting was a four-person panel discussion focused on [Behavioral Health Services during COVID-19](#).

Much of our work is accomplished through **Interest Groups**, where we provide settings, information, and connections to produce and nourish new approaches and collaborations to strengthen Aurora's healthcare system. Areas of focus for the Interest Groups are determined by community needs, member-identified priorities, and capacity to make a difference in an area.

This group focuses on understanding and addressing the barriers to accessing specialty care services. In 2020, a small group of attendees collaborated and launched a **Special Needs Assessment** to determine the obstacles that medical providers face in securing specialty care for their patients. Also, the group hosted a **3-part webinar series** focused on **e-consultations**, featuring national, local, and member perspectives.

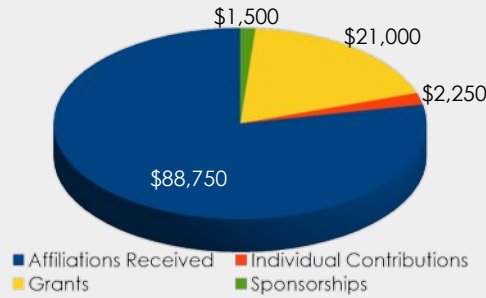

# AHA 2020 Budget & Membership

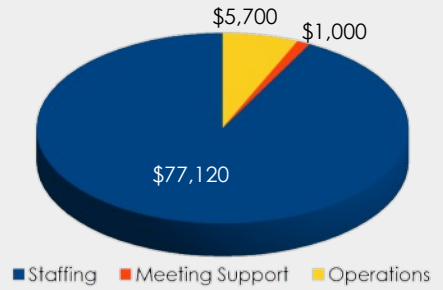
Thanks to **Aurora Mental Health Center** for serving as AHA's Fiscal Sponsor.

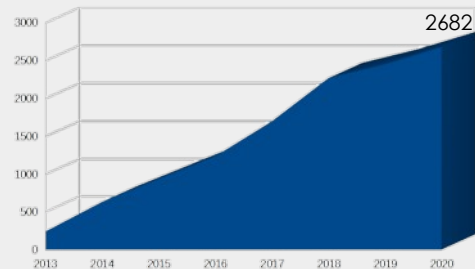
AHA Revenues 2020
