



Specialty Care Needs Assessment

What / Why / How

In 2019, after a presentation around state-wide unmet specialty care access needs, several members of the Access to Specialty Care Interest Group noted than an Aurora-specific needs assessment was necessary. Existing data and reports characterizing specialty care needs in Aurora were collated and a Specialty Care Access Survey was created and distributed to a comprehensive list of clinics and providers serving Medicaid and uninsured Aurora residents.

Existing Data:

- CU Specialty Clinic Waitlist Data 2021
- Department of Healthcare Policy and Financing Regional Accountable Entity Specialty Care Survey 2019
- Colorado Safety Net Collaborative Specialty Care Survey 2019

Survey Part 1 (Required)

- Top 5 unmet specialty care needs
- Least problematic /easiest to access specialty care areas
- Top 3 areas most expensive diagnostic tests /procedures for uninsured patients

Survey Part 2 (Optional)

- Barriers and Solutions open ended questions
- Rank list of barriers and solutions using a standardized survey (Timble et al. 2020)

Respondents

- 54 respondents, 15 clinics represented
- 59% respondents from Aurora Federally Qualified Health Centers (FQHCs)
- Roles: 55% primary care providers, 45% other team members
- 67% responded to both Parts 1 and 2



All specialty areas are an issue; given a chance to rank top 5 unmet needs, every specialty was mentioned at least once by Medicaid patients

Top 3 unmet needs for expensive tests/ diagnostic procedures for uninsured patients

- Endoscopy/ Colonoscopy
- Cardiac Testing*
- MRI/CT Scans

What's working better? Three <u>least</u> problematic specialties / lowest three needs for both **Medicaid** and **uninsured**:

- Obstetrics
- Cardiology*
- Ophthalmology

*The survey results identified Cardiology in both sections, resulting in a need for further study.

Takeaways

- The system does not function successfully for patients
- There are not enough specialists serving Medicaid and/or uninsured individuals
- Lack of transparency in the system about capacity limitations is a primary barrier
- Cost and lack of cost data is a significant barrier for uninsured populations

Recommendations / Call to Action

- Create a transparent network map for Aurora
- Create a collective list of available Medicaid / uninsured network providers with clear policies and capacity (Suggestion: dedicated staff for network building and maintenance)
